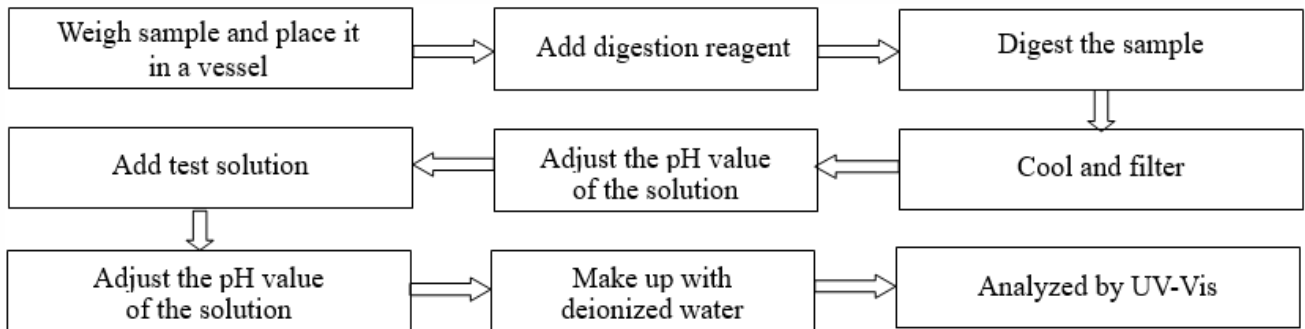

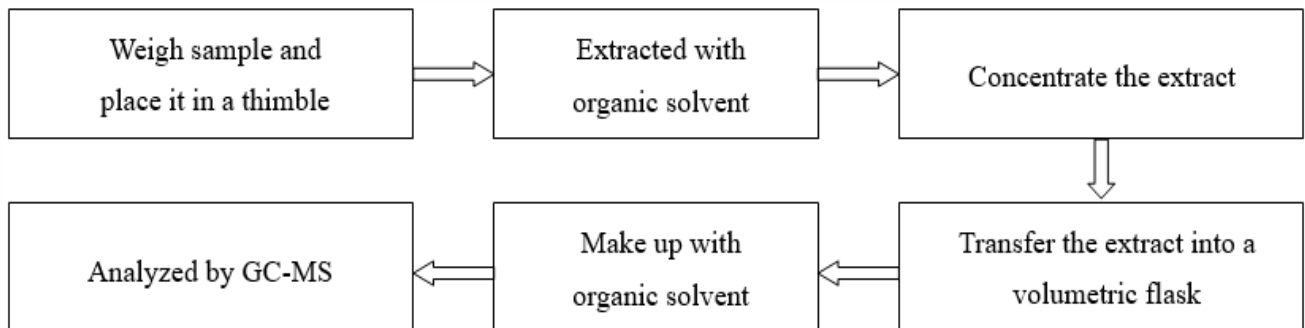
**2. Mercury (Hg)**

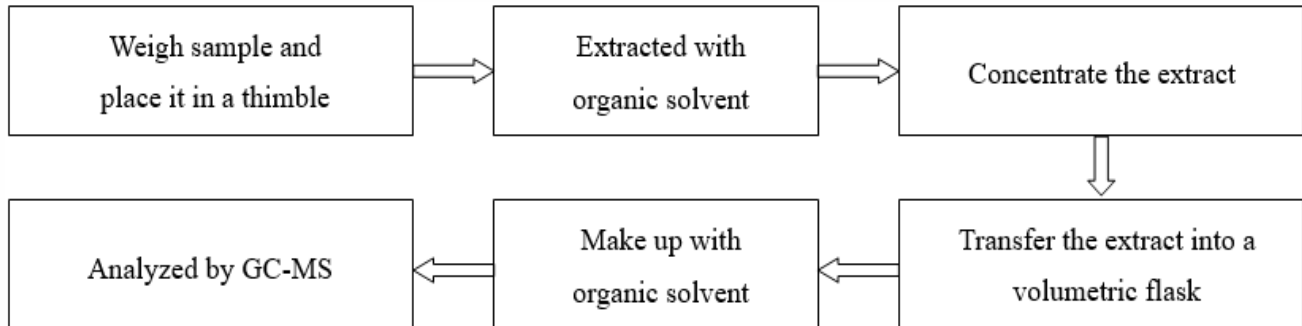

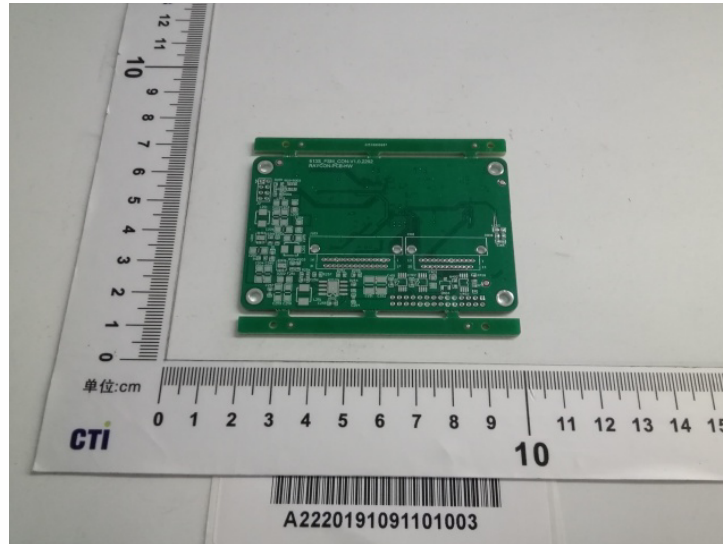
